Declaration of consent under data protection law in the context of the company-internal childcare Kids @ AIDS Conference 2024

The processing of all personal data transmitted to us takes place exclusively within the framework of the legal provisions of data protection law. All data protection law terms below correspond to the definitions in Art. 4 DSGVO.

Person responsible and data categories

Responsible for data processing in the sense of the data protection laws is: Events4Kidz GmbH, Bürgermeister-Wild-Strasse 35, 85521 Ottobrunn (named below as Events4Kidz). You can reach our data protection officer at hallo@events4kidz.com or via our postal address with the addition of "the data protection officer".

Subject of data protection / data categories

The subject of data protection is the processing of personal data. This is any information relating to an identified or identifiable natural person so-called data subject. Events4Kidz processes the following category of personal data: Contact details, including my full name, email address, telephone number, such as my registration address, my child's full name and my child's date of birth.

Master data: in particular your name, first name, such as surname, first name and date of birth of your child/children.

Contractual data: in particular, data that you provide to us for the performance of a contract

Content data: in particular data exchanged in correspondence between us.

We process personal data in compliance with the relevant data protection regulations. This means that your data will only be processed by us in the presence of this consent.

Purpose of processing

Events4Kidz processes personal data for the following purposes: organization of the AIDS childcare program. In this respect, the processing of your personal data takes place on the basis of Art. 6 para. 1 lit. b) DSGVO, insofar as it is necessary for the above-mentioned purposes.

Retention periods / fulfillment of legal obligations

Based on your consent, personal data will be stored for a maximum of two years, unless longer storage is necessary to fulfill the purpose for which the data was collected or to comply with statutory retention obligations (e.g. commercial and tax retention obligations). In this respect, data processing is carried out on the basis of Art. 6 para. 1 lit. c) DSGVO. We delete the data after the legal obligation no longer applies.

Receiver

Events4Kidz only passes on personal data to external third parties if this is necessary to process the contract (e.g. workshop providers, excursion destinations, passenger transport service providers, etc.) or if there is legal permission. In this case, the transfer is made on the basis of Art. 6 (1) a), b), c) and/ or f) DSGVO. External recipients may also be service providers that we commission to provide services within the scope of order processing pursuant to Art. 28 DSGVO (e.g. tax consultants, data center operators and further IT service providers). Furthermore, for legally compelling reasons, personal data may be transferred to public authorities and state institutions, such as customs or tax authorities, public prosecutors, courts or funding agencies, etc.

I hereby consent to the collection and processing of my personal data within the scope and for the purposes stated above.

I have taken note.

I am aware that the declaration of my consent is voluntary and that I have the right to revoke it at any time with effect for the future. For this purpose, it is sufficient to send a message to Mail: hallo@events4kidz.com.

In the event that consent is revoked, Events4Kidz may only further process your personal data if there is another legal basis for doing so.

Right to information, correction, deletion or restriction of your personal data, right to object and right to data portability

Under applicable data protection law, you may have the right:

- i. request confirmation as to whether Events4Kidz is processing personal data about you and to receive information about the personal data processed by Events4Kidz and further information,
- ii. request the correction of inaccurate personal data,
- iii. request the erasure of personal data processed by Events4Kidz, iv. request the restriction of the processing of personal data by Events4Kidz,
- iv. request the erasure of personal data processed by Events4Kidz, iv. request the restriction of the processing of personal data by Events4Kidz,
- v. object to the data processing of your personal data by Events4Kidz.

Clothing

Please bring a short as well as long leg clothing, socks and a change of top for your child/children. Parents/guardians must label all clothes and toys brought to the childcare room with the child's name. No valuable items can be left with the child in the childcare facility.

Shoes

Provide your child/ your children with sturdy, closed-toe shoes that allow us to romp and run freely.

Backpack

Please make sure to give your child/ your children a backpack suitable for children.

Food and Beverage

It is important to us, that you provide your child/ children with beverage, breakfast, a midday meal an afternoon snack and a Dinner. Food and snacks will not be provided as part of the childcare services. Parents/ guardians must provide the necessary food for their child(ren) for the time they are placed in the childcare facility. The caregivers will provide the child(ren) only with food and snacks provided by the parents/guardians.

A water dispenser will be available in the childcare area. If parents/guardians want to bring any other drink, they must provide the drink, and the caregivers will give it to the child(ren).

Emergency

If you need to contact your child/ your children due to an emergency, we are available at +49(0)89-62836130.

Illness of a child/ prevention

For the health of other children in care, sick children will not be allowed into the childcare facility. Please call +49 (0)89-62836130 for this purpose.

Nappy changing

Nappies will not be changed as part of the childcare services. Caregivers will immediately call the parents/guardians, who must return to the childcare facility to change their child.

Health insurance

Parents/guardians are required to have their own medical insurance, which fully covers their child(ren), including any medical or hospitalization expenses, repatriation in case of medical emergency and accident causing permanent disability or death.

Liability insurance

The parents/guardians will be responsible for any damage caused by their children at all times.

The parents/guardians' liability insurance shall include the coverage for all damages to personal belongings by their child(ren)'s own carelessness or negligence (for example, a child stumbles and shatters their or another child's spectacles, or a child damages their own or another child's clothes), loss of personal belongings and theft of belongings.

Liability

Except in case of gross negligence or wilful misconduct, the International AIDS Society and Care4kidz shall not be liable for any damage caused. The parents/guardians agree to indemnify, defend and hold the International AIDS Society and Care4kidz harmless from and against any and all liability, loss and expense (including attorney's fees) or any claims arising out of or resulting from its activity and/or caused by their child.



Additional information

- It is the parent/guardian's responsibility to provide all important information related to the child (including allergies and special health conditions) when submitting the childcare booking form and to remind the caregiver on site of this information when checking the child into the childcare facility.
- For children with special needs, the childcare service provider reserves the right to decline an application, based on the capacity of the childcare services, on a case-by-case basis.
- The childcare services will not administer any prescription medicine to the children. A parent/guardian must return to the childcare facility to dispense any medicine to the child.
- Parents/guardians must provide a contact number where they can be reached at any time while the child is in the childcare facility. Parents/guardians must be available at any time to change their child or to collect their child from the childcare facility in case any problem occurs with the child in the childcare facility.
- Parents/guardians or any people authorized by the parents/guardians to check child(ren) in and out of the childcare facility must bring their passport or other ID.
