

Hosting HIVR4P 2026

Invitation to submit letter of intent to host HIVR4P 2026, the 6th HIV Research for Prevention Conference

The HIV Research for Prevention Conference is the only global scientific conference focused exclusively on the challenging and fast-growing field of HIV prevention research. This conference fosters interdisciplinary knowledge exchange on HIV vaccines, microbicides, PrEP, treatment as prevention and biomedical interventions, as well as their social and behavioural implications. The conference typically gathers approximately 1,500 participants.

Practical details

The IAS invites destinations in the Asia and the Pacific Islands region where ongoing HIV prevention research is taking place and which are interested in hosting HIVR4P 2026 to submit a letter of intent.

The letter of intent is expected to be no more than three pages and must include all the information and attachments listed below.

First, please ensure that you complete Attachment 2, which lays out the essential selection criteria of human rights and health, safety and political stability.

1. Legacy

- 1.1 Statement of interest
 Why is the destination interested in hosting the conference?
- 1.2 Composition of the bid committee



The bid committee of the destination should be composed of the convention bureau or similar, the convention centre, local civil society organization(s) and scientific partner organizations. It should be supported by the government and the private sector. What is the composition of your bid committee?

1.3 Visibility of the conference and high-level engagement

Outline the strategy and methods that you intend to use to achieve the most effective visibility of the conference in your city/region/country. What will be your approach to ensure the engagement of high-level stakeholders and celebrities in the conference?

1.4 Letters of support received

Please attach any letters of support. These could be letters from:

- Leaders of the bid committee indicating institutional support and commitment
- HIV professionals and civil society members working in the proposed city and country
- Relevant authorities in other sectors, such as government, health and the private sector

The bidding process

STEP 1: Letter of intent to host the conference

22 April 2024	Invitation to submit letter of intent
14 June 2024	Deadline for submission of letter of intent
End of July 2024	Shortlisting process. The IAS Conference Committee will propose a shortlist of 3-4 destinations to be approved by the IAS Executive Board.

STEP 2: Detailed proposals by shortlisted candidate cities

15 August 2024	The IAS sends a detailed request for proposal to each shortlisted candidate with a deadline for submission of the bid.
15 November 2024	Deadline for submission of bids
Q1 of 2025	Detailed technical analysis of bids Site visits Review and analysis of the bids by the IAS Conference Committee
Q1 of 2025	The IAS Executive Board confirms the successful host city.



Selection criteria

- Health, safety and political stability: A requirement is that the host city will work with us to ensure high-standard health and safety protocols for all delegates, staff and speakers in a politically stable climate.
- Human rights: A key selection criterion is that the host city provides a safe environment and equal treatment for people most affected by HIV. HIV disproportionately affects some of the most marginalized people, and finding an environment where such communities feel safe and can express themselves freely is central to selection.
- Legacy: The IAS wishes to provide a lasting scientific, community or political legacy for the destination. In other words, we wish to select destinations where the IAS can leave a meaningful legacy.
- Accessibility: The venue and related services must be accessible to all delegates, and immigration for delegates must be facilitated. We must have guarantees from the government that it will ensure fast-tracking processes and potentially a waiver of visa fees for our delegates.
- Logistics (venue, accommodation and transportation): In-person participation requires a venue, accommodation and travel infrastructure large enough to host such an event.
- Financial viability: The cost of the venue and logistics and confirmed financial support from the host country must enable a conference budget that ensures sufficient funding for participatory programme planning and scholarships.
- **Programmatic independence**: The Organizing Committee must be able to operate independently. It must be empowered to create a conference programme shielded from outside vetting or influencing.
- Sustainability: The host city has to be able to demonstrate its commitment to environmental and social responsibility.

The basic selection criteria of human rights and health, safety and political stability are covered in Attachment 2: Restrictions on the organization of IAS conferences. It is essential that you complete Attachment 2 as part of your letter of intent.

Please note that a detailed bid proposal, including programmatic independence, sustainability and more detailed funding information, is required only from shortlisted cities that received an invitation to submit a full proposal, as per Step 2 above.

The submission deadline for letters of intent is 14 June 2024.
